WHEREAS, Pulmonary hypertension (PH) is a rare but very complex and serious lung disease, which is progressive and potentially fatal. PH is defined by high blood pressure in the lungs, which leads to enlargement and weakness of the rightside of the heart—a serious type of heart failure. PH can strike people of all backgrounds, ages, and genders.

WHEREAS, common symptoms of PH (shortness of breath, bluish hands, feet and lips, chest pain, light-headedness, and extreme tiredness) are often misdiagnosed, delaying appropriate treatment.

WHEREAS, it is estimated that approximately 5,000 Canadians have been diagnosed with pulmonary hypertension, but as many as 10,000 may be affected by the condition.

WHEREAS, while there is currently no cure for PH, thanks to available treatments, many patients are living longer, healthier lives.

THEREFORE, I, Christa Lowry, Mayor of Mississippi Mills, do hereby proclaim May 5TH 2022 as World PH Day

The assessment made in the year 2022, based on current values from January 1, 2016 under the provisions of the Assessment Act, Chapter A.31, R.S.O. 1990 as amended, shall be the assessment on which the final tax rates shall be fixed and levied and the final tax shall be fixed and levied on such assessment.
- 3. That for the purpose of paying the debentures and amounts due under the Tile Drainage Act, the 2022 repayment amounts shall be shown as an addition to the final tax levy.
- 4. The net amount of taxes levied by this By-law shall be due and payable in two equal installments. The installment due dates for all tax classes is Thursday, July 28, 2022 and Thursday, September 29, 2022.

If any taxes levied pursuant to this By-law remain unpaid as of January 1st., 2023, interest at the rate of one and one-quarter percent (1.25%) of the unpaid taxes shall be charged on January 1st., 2023 and also on the first day of each calendar month thereafter for as long as the default continues.

 - i) Registered Plan of Subdivision 27M-99, Block 28, described as Parts 1, 2, 3, 4, 5, 6, 7 and 8 on Reference Plan 27R-11856, Almonte Ward, Municipality of Mississippi Mills, County of Lanark.
- 2. This By-law shall come into full force and take effect after the requirements of subsection 50(7.1) have been complied with.
- 3. This By-law shall be automatically repealed on the 17th day of May, 2025, unless the Council of the Municipality of Mississippi Mills has provided an extension by amendment to this by-law prior to its expiry.
