**E. ROUND TABLE**

Ian MacLean - provided background on the proposed archeological dig. Looking at other organizations to apply for the grant rather than the municipality. Members felt that applications for a grant should be submitted by indigenous organizations rather than the municipality. Members also did not feel that it would be an appropriate project for the bicentennial.

Sue Evans provided an update on the All My Relations project , the 7 Grandfather Teaching Sculptures. Members discussed the opportunity to include events around the unveiling and carving of the sculptures as part of the bicentennial projects. Members also identified this project as a potential option to submit an application to the Legacy Grant. Sue Evans will bring forward further details to the Working Group for consideration at an upcoming meeting.

Nathalie Cleroux brought forward ideas to bring indigenous artists to the community through existing events or galleries. Members considered how the municipality could support indigenous artists. Another option discussed was an electric pow wow and including it in an existing event scheduled for 2023. Nathalie Cleroux will bring forward artist fees at the upcoming working group meeting.

Members also discussed how to attract and involve youth in indigenous-related activities. Clerk Harfield will reach out to the local high school, Library and Youth Centre to see if there are options to partner, create co-op positions or encourage programs that would involve youth.
